



A degree student was killed in what the police described as a "crime of passion" in Kollam late on Monday. Febin George Go-mas, 21, a student of Fati-ma Mata College, Kollam, was allegedly stabbed to death by Tejas Raj, 24, on Monday night. Hours later Tejas Raj's body was found on the railway tracks near Chemmanmukku, around 3 km from the crime scene On Tuesday, the police said Tejas Raj, the accused in the Kollam murder-sui in the Kollam murder-sui-cide case, had come with the intention to kill the en-tire family. The victim's sis-ter and Tejas Raj were classmates and, reported-ly, both the families had discussed marriage. Though both attended bank conching classes, on-

bank coaching classes, on-ly the girl could clear the exam. Subsequently, there were disagreements bet-ween the girl and Tejas Raj. According to relatives, Tejas Raj's dominating cha-Tejas Raj's dominating cha-racter led to the breakup of the relationship and the girl's marriage was fixed with someone else. Right to development a priority under fundamental rights'

The Supreme Court set aside, in separate judgments on Monday, a National Green Tribunal (NGT) order and a Madras High Court decision to halt development activities at Auroville. The decision cited lack of environmental clearance while outlining the need for sustainable development which strike a "golden balance" between the rights to developand ment clean

environment.

"Though it is true that the precautionary principle and the polluter pays principle are part of the environmental law of the country, it is equally true that while the right to clean environment is a guaranteed fundamental right under Articles 14 and 21 of the Constitution, the right to development through industrialisation equally claims priority under fundamental rights, particularly under Articles 14, 19 and 21 of the Constitution," a Bench of Justices Bela M. Trivedi and P. B. Varale observed in their judgment. A Bench of Justices Trivedi and Varale set aside the April 2022 order of the NGT, Chennai, which directed the Auroville Foundation not to proceed with further construction in its township project until environmental clearance was obtained. Setting aside the NGT verdict of 2022, Justice Trivedi concluded that the Tribunal had "committed gross error in assuming the (Conservation) Act, 1980.

jurisdiction and giving directions untenable in law". The court, in a second judgment also delivered on March 17, upheld a separate appeal filed by The Auroville Foundation against a March 2024 order of the High Court.

In the judgment concerning the NGT order, the apex court explained that the grievance raised by the respondents was with regard to the construction of roads as mentioned in the Master Plan by the Foundation. Justice Trivedi noted the

Master Plan had been approved by the the Foundation and by the Minister of Human Resource Development back in 2001 and published in the official gazette in 2010.

The argument raised in the Tribunal against the construction was that it would destroy an area called the Darkali forest. The Foundation had countered that areas cannot be treated as a forest. They contended that it was a man-made plantation

which did not require environmental clearance mandated under the Forest The Supreme Court set aside orders from the National Green Tribunal (NGT) and the Madras High Court, which had halted development activities in Auroville due to environmental

concerns.

The ruling emphasized the **need** for a "golden balance" between the right to development and environmental protection.

Right to Development vs. Right to Clean Environment

The judgment stated that **both rights—clean environment and development—are fundamental under the Constitution**.

Industrialization and urban development are equally prioritized under Articles 14, 19, and 21.

While environmental laws, including the **precautionary principle** and **polluter-pays principle**, are valid, they **cannot override the right to development**.

Setting Aside NGT Orders

- The Supreme Court quashed the April 2022 NGT order, which had stalled township construction in Auroville until environmental clearance was obtained.
- The court criticized the NGT for overstepping its jurisdiction and issuing legally untenable directions.

Roads & Darkali Forest Dispute

- The grievance in the case was **related to road construction under Auroville's Master Plan**.
- The NGT had claimed that the construction would damage the Darkali forest.
- However, the Auroville Foundation argued that Darkali is a manmade plantation, not a natural forest, and thus did not require special environmental clearance under the Forest Conservation Act, 1980.



4. Master Plan Approval

The Supreme Court noted that the **Auroville Master Plan was approved in 2001** by both the Foundation and the Minister of Human Resource Development.

It was formally published in the official gazette in 2010, making it legally valid.





India takes 24th spot in free speech survey

A new global survey by the Future of Free Speech, an independent U.S.-based think tank, has ranked India 24th out of the 33 countries surveyed on the question of support for free speech. Its report, titled 'Who in the world supports free speech?' states that "while abstract support for free speech remains strong, commitprotecting ment to controversial speech is eroding in many parts of the world."

The survey, conducted in October 2024, also revealed that "more countries have seen declines rather than improvements in free speech support since 2021, with some of the biggest drops occurring in democratic nations like the United States, Israel, and Japan".

As regards its findings concerning India, the survey found that while a majority of Indians consider it very important to speak freely without government censorship, support for criticism of government policies was below the global average.

For instance, 37% of Indian respondents supported the statement that "governments should be able to prevent people" from criticising government policies – the highest percentage among all the countries surveyed.

Public sentiment

In contrast, 5% of the respondents supported this statement in the U.K., while only 3% endorsed this sentiment in Denmark.

In general, nations that are more supportive of free speech tend to enjoy more freedom of expression in

practice and vice versa. But India was an exception to this pattern. "The most substantial disconnects from the general pattern are represented by India, Hungary, and Venezuela where the actual protection of free speech is very low compared to the popular support. These are all cases of democratic backsliding in countries that previously demonstrated high levels of respect for political liberties, including freedom of expression," the report stated.

When asked whether their ability to speak freely about political matters has improved or worsened over the past year, "Indians and South Africans believe that they have undergone the most significant progress, although observers and rankings tend to agree that the situation in India has become worse, if anything," the report noted.

- India ranked 24th out of 33 countries in a global free speech survey conducted by the Future of Free Speech, a U.S.-based think tank.
- India's score: 62.6, placing it between South Africa (66.9) and Lebanon (61.8).
- The survey found that while most Indians value free speech without government censorship, support for criticizing government policies is below the global average.

Global Trends

- Scandinavian countries (Norway & Denmark) ranked highest, with scores of 87.9 and 87.0.

India's Standing & Key Observations

- 37% of Indian respondents agreed that "governments should be able to prevent people" from criticizing government policies—the highest percentage among all surveyed nations.
- In contrast: Only 5% in the U.K. and 3% in Denmark supported such restrictions.
- The report flagged a disconnect between India's popular support for free speech and actual protection of speech.
- India, Hungary, and Venezuela were identified as examples of "democratic backsliding" where legal protections for free speech are weaker than public demand.

Public Sentiment in India

When asked whether their ability to speak **freely about politics** has improved or worsened:

- Many Indians and South Africans said the situation has improved.
- However, global observers ranked India among countries where free speech has deteriorated.

It underscores addiction as a **chronic brain condition** rather than a **moral failing**, paving the way for more effective treatment strategies.

How Does Neuroscience Explain Addiction?

Role of Brain in Addiction: The study highlights 3 key brain regions involved in addiction i.e., basal ganglia, extended amygdala, and prefrontal cortex.


- Basal Ganglia: It teaches the brain to repeat pleasurable activities, whether from food, social interaction, or addictive substances.
 - It works with neurotransmitters like **dopamine and serotonin** to reinforce pleasurable behaviors.

Extended Amygdala:

It triggers **anxiety, irritability, and unease** when substance use stops, pushing **continued use despite harm**.

- Prefrontal Cortex: It explains why substance use continues despite knowing its harmful effects, a key trait of addiction.
 - The prefrontal cortex, which handles decision-making, time management, and prioritization, **completes the triad**.

Brain Regions Affected by Addiction



Vulnerability to Adolescents:

Adolescence represents a **critical "at-risk period"** for substance use because the **brain is still developing.**

 The prefrontal cortex, which controls impulses and decisionmaking, matures last. This makes teens more vulnerable to addiction.

- Other Reasons of Addiction:
 - Genetic Predisposition: Some individuals are biologically more prone to addiction.
 - **Psychological Factors: Trauma, stress, and mental health disorders** increase vulnerability.
 - Environmental Influences: Family history, peer pressure, and socioeconomic conditions play a significant role.
 - Age of First Use: Earlier exposure increases the risk of long-term dependency.


